

Regular Board Meeting – February 21, 2018

Board President Romaine Graham reported that in accordance with P.L. 1975, Chapter 231, adequate notice of this meeting was posted in the Administration Building and copies of said notice sent to the Irvington Herald, the Star Ledger, and Township Clerk.

Principal Malikita Wright welcomed all to the meeting and recognized the Madison Avenue School parents and staff in attendance. She stated her tenure at Madison was short but she could already see they had committed and extraordinary teachers there. She noted a few Madison Avenue Scholars would perform a song “Future” in honor of Black History Month and that the newly formed cheerleading squad and Step Squad would perform to Beyonce’s “Freedom”.

SUPERINTENDENT’S REPORT

Dr. Neely Hackett began her report by acknowledging the performance of the students and then presenting the Student Trustee for her report on Irvington High School.

Faith Northern, Student Trustee reported that February was the month they were learning about “Motivation”. She stated that advisory lessons and various other activities allowed the students to better understand the trait for their emotional and social development. Next she said National Signing Day was held Wednesday, February 7th. Nine senior football players were awarded scholarships to various colleges and universities and on that day they signed their letters of intent for their respective school. On February 9th, 48 students traveled to Princeton University to do a college tour and attend the art museum.

This trip was sponsored by Mr. Jim Petrucci. Faith then stated the Consumer Bowl Team won its tenth consecutive Essex County Championship. The team is directed by Mr. Romano. On February 16th a pep rally was held to honor Irvington Sports. She finalized her report by noting that on Monday, February 12th, IHS celebrated Black History Month and Women's History Month with performances by the Visual and Performing Arts Department.

Dr. Hackett resumed her report by honoring many of the educators of the district. She noted several would be addressed at the March meeting. For this meeting however, she highlighted Mr. Angoy and Ms. Bennin.

IRVINGTON HIGH SCHOOL WINS THE 2018 ESSEX COUNTY CONSUMER BOWL CHAMPIONSHIP TITLE

For the 10th straight year, the Irvington High School Consumer Bowl Team has won the Essex County Championship. The New Jersey Division of Consumer Affairs has sponsored the event since 1997. The Consumer Bowl is a fun, game show style competition that tests students' knowledge about consumer laws and fraud. The students who participate in the consumer bowl learn invaluable information that they can use to protect themselves and their families now and in the future.

2016-2017 DISTINGUISHED TEACHERS

This evening, I would like to recognize 71 staff members of the Irvington Public Schools who received a Distinguished rating on their 2016-2017 summative evaluation. The summative evaluation is the culmination of 2 evaluations for tenured teachers and 3 evaluations for non-tenured teachers. Staff members are rated in 4 Domains and a score ranging from 1-4 is given for each Domain. In order to receive a Distinguished rating, a staff member must score 3.5 or higher on a scale of 1-4. I am pleased to honor the staff members this evening who have demonstrated excellence in their respective roles. I would like to thank these staff members for their hard work and efforts and encourage them to share their talent with other staff members through mentoring, professional development and peer coaching. You are the key to Irvington's success in providing our scholars with an education that will prepare them to be 21st Century learners and thinkers.

2018-2019 SUPPORT PROFESSIONAL OF THE YEAR-JAMALL ANGOY

Jamal Angoy has worked in the Irvington Public Schools for 11 years. He currently serves as a guidance counselor at Irvington High School.

Mr. Angoy has a desire to help students understand critical aspects of life such as knowing and being themselves, career and financial awareness, and decision making followed by taking action. In order to make his desires a reality, he needed a platform that would allow him to reach as many students as possible, and that platform would be the role of a guidance counselor.

Mr. Angoy understands that in order to reach students, he must first build positive and supportive relationships. He understands the need to earn students' trust, respect, and admiration. It is through the development of sustainable relationships with students that Mr. Angoy is able to educate students about the life skills necessary for success.

Mr. Angoy gives his students the following advice to live by:

1. Listen and then listen again
2. Speak of what you want into existence and take the necessary action
3. You are not entitled to anything
4. You can only deserve what you earn
5. Motivate and then educate
6. People are always the priority
7. Know yourself

In Mr. Angoy's essay for the Support Professional of the Year, he said the following "It is not my position to teach Advanced Placement Calculus or Biology Honors but I always teach Advanced Placement Successful Life Skills, Career Awareness Honors, and Advanced Placement Self- Exploration.

Mr. Angoy believes that he is the change that he wants to see in the world and his world away from home is Irvington High School.

Mr. Angoy thanked the Board, Dr. Hackett, Principal Ms. Michialidis, and Guidance Supervisor Ms. O'Brian, the district educators, the entire guidance department and Ms. Wright for hosting the meeting. He mentioned being a product of his environment. He said he looks at the students as him 15 years removed. He went to Madison, Myrtle, IHS, college and was back to contribute to Irvington. He said nothing was possible without the teachers in the classroom and asked for applause for those honored. He ended with a cheer from the audience of "Irvington Family"!

2018-2019 TEACHER OF THE YEAR-THERESA BENNIN

Ms. Bennin has worked in the Irvington Public Schools for 17 years. She currently serves as a chemistry teacher at Irvington High School

Ms. Bennin believes that education is the key to a successful future and that teaching and learning are integral to this process. Her guiding principal is to make the students under her tutelage productive and proactive citizens. She believes that the best gift that she can give to students is to share her knowledge. She is encouraged on a daily basis by knowing that her students' lives are being altered in very meaningful ways.

An example of this is that Ashley Reid, the IHS Class of 2017 Salutatorian who received a scholarship to study Chemistry at Fairleigh Dickinson University indicated that she was inspired to major in Chemistry because of her experiences in Ms. Bennin's Chemistry Honors and Advanced Placement Chemistry classes.

Ms. Bennin extends herself beyond her job description to do whatever is necessary to improve the learning experiences of her students:

1. She applied for and was awarded the American Chemical Society grant for two years in a row 2016 and 2017. The funds have been used to purchase supplemental equipment for the Chemistry Laboratory at the high school
2. She prepares students each year to participate in the American Chemical Society's Project Seed. Project Seed is a five-week summer program where students work with local researchers and are introduced to careers in science. Students receive stipends that range from \$2,500 to \$3,000. Eighteen (18) students gone through Project Seed, under Ms. Bennin's guidance in the last three years.
3. She serves as a mentor for new teachers

In addition to delivering a rigorous instructional program, Ms. Bennin also counsels her students regarding the social skills necessary to be productive and proactive citizens.

Ms. Bennin believes that her role in the Irvington Public Schools is multi-faceted; she is an educator, mentor, counselor, and role model.

Ms. Bennin noted she loves what she does. She said she did not plan to teach, but going into a classroom and seeing the enthusiasm of the students changed her. She believes that every student can learn and believes by what Dr. Hackett talks about with the Starfish. She does whatever it takes to get to that starfish, in this case the student to help them learn. She was humbled by the recognition because she loves the opportunity to work with the students.

CLASSIFICATION DEFINITIONS

1. "Auditorily Impaired" corresponds to "auditorily handicapped" and further corresponds to the Federal eligibility categories of deafness or hearing impairment. "Auditorily impaired" means an inability to hear within normal limits due to physical impairment or dysfunction of auditory mechanisms characterized by (c)1i or ii below. An audiological evaluation by a specialist qualified in the field of audiology and a speech and language evaluation by a certified speech- language specialist are required.

i. "Deafness"--The auditory impairment is so severe that the student is impaired in processing linguistic information through hearing, with or without amplification and the student's educational performance is adversely affected.

ii. "Hearing Impairment"--An impairment in hearing, whether permanent or fluctuating which adversely affects the student's educational performance.

2. "Autistic" means a pervasive developmental disability which significantly impacts verbal and nonverbal communication and social interaction that adversely affects a student's educational performance. Onset is generally evident before age three. Other characteristics often associated with autism are engagement in repetitive activities and stereotyped movements, resistance to environmental change or change in daily routine, unusual responses to sensory experiences and lack of responsiveness to others. The term does not apply if the student's adverse educational performance is due to emotional disturbance as defined in (c) 5 below. A child who manifests the characteristics of autism after age three may be classified as autistic if the criteria in this paragraph are met. An assessment by a certified speech-language specialist and an assessment by a physician trained in neurodevelopmental assessment are required.

3. "Intellectually Disabled" means a disability that is characterized by significantly below average general cognitive functioning existing concurrently with deficits in adaptive behavior; manifested during the developmental period that adversely affects a student's educational performance and is characterized by one of the following:

i. "Mild Intellectual Disability" means a level of cognitive development and adaptive behavior in home, school, and community settings that are mildly below age expectations with respect to all of the following:

- (1) The quality and rate of learning;
- (2) The use of symbols for the interpretation of information and the solution of problems; and
- (3) Performance on an individually administered test of intelligence that falls within a range of two to three standard deviations below the mean.

ii. "Moderate Intellectual Disability" means a level of cognitive development and adaptive behavior that is moderately below age expectations with respect to the following:

- (1) The ability to use symbols in the solution of problems of low complexity;
- (2) The ability to function socially without direct and close supervision in home, school and community settings; and
- (3) Performance on an individually administered test of intelligence that falls three standard deviations or more below the mean.

iii. "Severe Intellectual Disability" means a level of functioning severely below age expectations whereby in a consistent basis the student is incapable of giving evidence of understanding and responding in a positive manner to simple directions expressed in the child's primary mode of communication and cannot in some manner express basic wants and needs.

4. "Communication Impaired" corresponds to "communication handicapped" and means a language disorder in the areas of morphology, syntax, semantics and/or pragmatics/discourse which adversely affects a student's educational performance and is not due primarily to an auditory impairment. The problem shall be demonstrated through functional assessment of language in other than a testing situation and performance below 1.5 standard deviations, or the 10th percentile on at least two standardized language tests, where such tests are appropriate, one of which shall be a comprehensive test of both receptive and expressive language. When the area of suspected disability is language, assessment by a certified speech-language specialist and assessment to establish the educational impact are required. The speech-language specialist shall be considered a child study team member.

i. When it is determined that the student meets the eligibility criteria according to the definition in (c) 4 above, but requires instruction by a speech-language specialist only, the student shall be classified as eligible for speech-language services.

ii. When the area of suspected disability is a disorder of articulation, voice or fluency, the student shall be evaluated according to N.J.A.C. 6A:14-3.4(g) and, if eligible, classified as eligible for speech-language services according to N.J.A.C. 6A:14-3.6(a).

5. "Emotionally Disturbed" means a condition exhibiting one or more of the following characteristics over a long period of time and to a marked degree that adversely affects a student's educational performance due to:

- i. An inability to learn that cannot be explained by intellectual, sensory or health factors;
- ii. An inability to build or maintain satisfactory interpersonal relationships with peers and teachers;
- iii. Inappropriate types of behaviors or feelings under normal circumstances;
- iv. A general pervasive mood of unhappiness or depression; or
- v. A tendency to develop physical symptoms or fears associated with personal or school problems.

6. "Multiply Disabled" corresponds to "multiply handicapped" and "multiple disabilities," and means the presence of two or more disabling conditions, the combination of which causes such severe educational needs that they cannot be accommodated in a program designed solely to address one of the impairments. Multiple disabilities includes cognitively impaired-blindness, cognitively impaired-orthopedic impairment, etc. The existence of two disabling conditions alone shall not serve as a basis for a classification of multiply disabled. Eligibility for speech-language services as defined in this section shall not be one of the disabling conditions for classification based on the definition of "multiply disabled." Multiply disabled does not include deaf-blindness.

7. "Deaf/blindness" means concomitant hearing and visual impairments, the combination of which causes such severe communication and other developmental and educational problems that they cannot be accommodated in special education programs solely for students with deafness or students with blindness.

8. "Orthopedically Impaired" corresponds to "orthopedically handicapped" and means a disability characterized by a severe orthopedic impairment that adversely affects a student's educational performance. The term includes malformation, malfunction or loss of bones, muscle or tissue. A medical assessment documenting the orthopedic condition is required.

9. "Other Health Impaired" corresponds to "chronically ill" and means a disability characterized by having limited strength, vitality or alertness, including a heightened alertness with respect to the educational environment, due to chronic or acute health problems, such as attention deficit disorder or attention deficit hyperactivity disorder, a heart condition, tuberculosis, rheumatic fever, nephritis, asthma, sickle cell anemia, hemophilia, epilepsy, lead poisoning, leukemia, diabetes or any other medical condition, such as Tourette Syndrome, that adversely affects a student's educational performance. A medical assessment documenting the health problem is required.

10. "Preschool Child with a Disability" corresponds to preschool handicapped and means a child between the ages of three and five who either:

i. Is experiencing developmental delay, as measured by appropriate diagnostic instruments and procedures, in one or more of the areas in (c) 10 i (1) through (5) below, and requires special education and related services. When utilizing a standardized assessment or criterion-referenced measure to determine eligibility, a developmental delay shall mean a 33 percent delay in one developmental area, or a 25 percent delay in two or more developmental areas.

- (1) Physical, including gross motor, fine motor and sensory (vision and hearing);
- (2) Intellectual;
- (3) Communication;
- (4) Social and emotional; and
- (5) Adaptive; or

ii. Has an identified disabling condition, including vision or hearing, that adversely affects learning or development and who requires special education and related services.

11. "Social Maladjustment" means a consistent inability to conform to the standards for behavior established by the school. Such behavior is seriously disruptive to the education of the student or other students and is not due to emotional disturbance as defined in (c) 5 above.

12. "Specific Learning Disability" corresponds to "perceptually impaired" and means a disorder in one or more of the basic psychological processes involved in understanding or using language, spoken or written, that may manifest itself in an imperfect ability to listen, think, speak, read, write, spell, or to do mathematical calculations, including conditions such as perceptual disabilities, brain injury, minimal brain dysfunction, dyslexia, and developmental aphasia.

i. A specific learning disability can be determined when a severe discrepancy is found between the student's current achievement and intellectual ability in one or more of the following areas:

- (1) Basic reading skills;
- (2) Reading comprehension;
- (3) Oral expression;
- (4) Listening comprehension;
- (5) Mathematical calculation;
- (6) Mathematical problem solving;
- (7) Written expression; and
- (8) Reading fluency.

ii. A specific learning disability may also be determined by utilizing a response to scientifically based interventions methodology as described in N.J.A.C. 6A:14-3.4(h)6.

iii. The term severe discrepancy does not apply to students who have learning problems that are primarily the result of visual, hearing, or motor disabilities, general cognitive deficits, emotional disturbance or environmental, cultural or economic disadvantage.

iv. The district shall, if it utilizes the severe discrepancy methodology, adopt procedures that utilize a statistical formula and criteria for determining severe discrepancy. Evaluation shall include assessment of current academic achievement and intellectual ability.

13. "Traumatic Brain Injury" corresponds to "neurologically impaired" and means an acquired injury to the brain caused by an external physical force or insult to the brain, resulting in total or partial functional disability or psychosocial impairment, or both. The term applies to open or closed head injuries resulting in impairments in one or more areas, such as cognition; language; memory; attention; reasoning; abstract thinking; judgment; problem-solving; sensory, perceptual and motor abilities; psychosocial behavior; physical functions; information processing; and speech.

14. "Visually Impaired" corresponds to "visually handicapped" and means an impairment in vision that, even with correction, adversely affects a student's educational performance. The term includes both partial sight and blindness. An assessment by a specialist qualified to determine visual disability is required. Students with visual impairments shall be reported to the Commission for the Blind and Visually Impaired.

14. ESSEX JUNIOR ACADEMY (ERESC) – ALTERNATIVE EDUCATION– GENERAL EDUCATION
