VIRTUAL Budget Hearing Meeting – March 29, 2023

Mr. Sylvain asked about the differences in amounts listed. He was informed by Mr. Lamptey that the difference had to do with Title I.

Mrs. Beasley asked about Little Ivy Academy to introduce STEAM education to K-8. Mr. Lamptey indicated it was one of the programs for the district and Dr. Adegboyega explained that the program prepares the little scholars. They have a specified classroom there they bring in the equipment, they bring their own staff where there in hands on activity during the school hours, after school hours and during the summer to bring up the literacy level for the STEAM program.

DISTRICT BUDGET STATEMENT FOR 2023-2024

RESOLVED, that the Irvington Board of Education accepted the recommendation of the Superintendent of Schools to adopt the proposed District Budget for the 2023-2024 school year in the amount of \$182,269,065.00 for the General Fund, of which \$17,459,529.00 shall be funded by local tax levy (no increase).

BE IT FURTHER RESOLVED that the Irvington Board of Education has allotted maximum travel expenditure for the 2023-2024 school year of \$75,000.00, district wide.
